## 183-06/23 Public participation.

To allow up to 10 minutes (2 minutes per person) for any members of the public and councillors declaring the existence and nature of a prejudicial interest to address the meeting in relation to the business on this agenda.

A question was asked with regards to Glebe Paddock and how the Parish Council intend to raise the funds to purchase it. The Chairman expressed confidence that this would be achievable over the next couple of years given the success of past funding applications. The licence option was explained to all present and it was further explained that the intention is to have an initial licence for 3 years; to be extended beyond that if required on a year by year basis. The Chairman is to report back to the Parish Council at the July meeting once a valuation has been obtained and we have confirmation that the Licence has been granted.

Councillor Awit joined the meeting.

# 184-06/23 To receive reports from county and district councillors.

Report from Councillor Costello:

- No mow May is now over so parishioners will see the grass verges start to be cut.
- An appeal for foster carers in Cambridgeshire is being made as there is a shortage. Parish Councils asked to advertise this where possible.
- A mentoring system has been set up for care leavers once they have left their care home. Details can be found on Cambridgeshire County Council website.
- Electric vehicle charging points are being installed all over the county.

### 185-06/23 Notification of planning items.

185-06/23.1 21/00572/FUL - Application for full planning permission for demolition of existing redundant building and infrastructure and residential development of 321 dwellings with associated highways, infrastructure and open space | Upwood Hill House and part of RAF Upwood (deferred from minute ref.: 154-04/21.1).

Comments - No updates on this application, so we will defer until next month's meeting.

185-06/23.2 23/00698/FUL - Erection of detached dwelling with detached garage/Land at Highfield, Raveley Road, Great Raveley.

Parish Council response – The Council considered this application against the previous application for a dwelling in this location. The Council felt that as the proposed development is set back from the main road, it is in a better position than the previous proposed location.

The Highways Officer is preparing the paperwork for the legal consultation period. Councillor Corney has confirmed his support for this application.

187-06/23 To discuss the Local Plan with the information that we have received thus far and following the first meeting with HDC on the matter.



The Clerk gave an overview of the meeting that was held on the 24th of May at HDC. It was felt that it was quite broad and that there was no discussion about individual parishes. General concerns were made about the lack of infrastructure such as, school places, doctors and dentists, all of which are oversubscribed.

Councillors noted that there was nothing specific for our Parish council at this time and agreed with the general concerns raised.

# 188-06/23 Community.

188-06/23.1 To discuss the refurbishment of the Bentley Close Play area:

Councillor Mashford confirmed that the relevant paperwork is with the lawyers at HDC.

There were discussions on sound attenuation and possible measures that could be implemented to help such as plants, shrubs or fencing.

The Council noted that the grant awarded is currently less than the overall cost of the work, due to the increase in materials. Councillor Mashford is looking at ways to reduce this.

It was agreed that the Council would hold an informal meeting with residents to discuss the refurbishment plans and answer any questions. It was agreed that this would be held at 7.15pm for 15 minutes at the June 2023 meeting. It was agreed that any points for discussion will be addressed in the formal meeting afterwards.

For the existing play area at Bentley Close, unfortunately due to vandalism, the Parish Council have had to make the decision to temporarily close the play area as it is unsafe for children to use at present. A few of the councillors have agreed to look at the damage and see if they can temporarily repair it. The incident of vandalism has been reported to the police.

## 189-06/23 Correspondence and Communications.

The Clerk received correspondence from a member of the public regarding an incident that occurred at the Huntingdon Road/Raveley Road junction, on 03 June 2023 at 17:15. An elderly gentleman in a silver car pulled out of the junction and into a red car where he has caused damage to the front driver side. The Parish Council noted an appeal for witnesses and have asked that if anyone caught the incident on their dashboard camera, or if they know the owner of the silver car, to please contact the Parish Clerk.

A resident contacted the Parish Clerk regarding concerns with cutting of the grass area near their house. Councillor Awit has followed up on this matter and is working with the contractors to resolve this.
