Non accessible content

Non-compliance with the accessibility regulations

The content listed below is non-accessible for the following reasons: PDF documents dated prior to 01 March 2020 do not meet accessibility standards. They may not be structured with bookmarks so navigation with screen readers may be compromised. This does not meet WCAG 2.1. Many of these documents are not essential to the provision of our services and the accessibility regulations do not require us to fix PDFs or other documents published before 23 September 2018 if they are not essential to providing our services. All new PDFs or Word documents we publish will meet accessibility standards.



Disproportionate burden

Many of the parish council's "policies and procedures" documents are not essential to the provision of our services and many were published prior to 23 September 2018. It would be a disproportionate burden to revise each of these at this time. These PDF documents may not be structured with bookmarks so navigation with screen readers may be compromised. This does not meet WCAG 2.1. All revised or new PDFs or Word documents we publish will meet accessibility standards.

PDFs and other documents

Many of our older PDFs and Word documents do not meet accessibility standards - for example, they may not be structured to be fully accessible to a screen reader. This does not meet WCAG 2.1 success criterion 4.1.

Content not within scope of the accessibility regulation

The accessibility regulations <u>do not require us to fix PDFs or other documents published before 23 September 2018</u> if they're not essential to providing our services. For example, we do not plan to fix documents in the minutes archives. Any new PDFs or Word documents we publish will meet accessibility standards.

How we tested this website

This website was last tested during February and March 2020. The test was carried out by Upwood and the Raveleys Parish Council.

What we're doing to improve accessibility:

Upwood and the Raveleys Parish Council is confident that its website is fully accessible but recognises that it has some partially inaccessible documents. It is not a legal requirement to publish many of these documents. They are published simply to provide additional information to interested residents. All revised and new documentation published from 01 March 2020 will be fully accessible and compliant with Public Sector Bodies (Websites and Mobile Applications) (No. 2) Accessibility Regulations 2018.
