# Upwood and the Raveleys Parish Council

### Clarke's F. A., Common Right, Settle of.

The Clerk's letter of October 13<sup>th</sup> last to Mr. F. A. Clarke, his reply of the 14<sup>th</sup>, and the Clerk's letter of October 20<sup>th</sup>, together with Mr. Clarke's receipt for 18/- in settlement of amount of all Common Rights due to him, up to, and including Michaelmas 1903, were submitted.

**Top Field - Debit & Credit Account.**

In compliance with instructions given at the previous meeting, the Clerk submitted an approximate Statement of Income from, and expenditure on the Top Field, and it being considered that debit items to the amount of £3.0.9 might fairly be spread over three years at least, and dealing with them accordingly, the account showed a debit balance (or loss) of 12/6 for the twelve months ended October 11<sup>th</sup> 1903.

**Land Tax – Exemption from.**

Proposed by Mr. Reginald J. Kidman, seconded by Mr. William Thompson, and resolved that minutes of the last Meeting as read, be confirmed and signed.

## **Representative School Manager – Election of.**

Proposed by Mr. William Thompson, seconded by Rev'd J. F. Cooksey, and resolved that John Evison Esq're be elected Representative Manager for the Upwood (non-provided) School for the three years ending April 15<sup>th</sup> 1907, in succession to Mr. William Collett resigned.

An amendment to the foregoing , proposed by the Chairman was not seconded.

## **Correspondence.**

Miss Setchell's letter of April 27<sup>th</sup> in reply to the Clerk's letter of April 20<sup>th</sup>, was read, and payment of Common Rights to her, as Representative of the late Thomas Setchell was approved.

Mr. E. W. Hunnybun's letter dated June 1904 enclosing print of Basis of Standard of County Rate, and Notice of Audit dated July 9<sup>th</sup> 1904, fixing same for the 29<sup>th</sup> inst. were submitted.

## **Account.**

Proposed by Mr. William Collett, seconded by Rev'd J. F. Cooksey, and resolved that cheque be signed and paid to the Overseers of the Poor, Rate on £25/5/- @ 10d in the £ = £1.1.0

The Clerk pointed out that the gross rents from the property on which the above was paid was only £17.14.9½ .

**Kilby, Chas. Charge on buildings.**

Proposed by Mr. Reginald J. Kidman, seconded by Mr. William Collett, and resolved that Charles Kilby be charged One Shilling (1/-) per annum for buildings on Bottom Allotment land, payable next Michaelmas, and annually thereafter so long as they remain.

**Cattle Straying, Authority for dealing with.**

Proposed by Mr. Reginald J. Kidman, seconded by Mr. William Collett, and resolved that complaints having been made of Cattle straying on the Allotments, the Council be and are hereby authorised to bring it under the notice of the police, and take such steps afterward as may be advisable.

**Reported burial scandal.**

Proposed by Mr. Reginald J. Kidman, seconded by Mr. William Collett, and resolved that reported scandal on the burial of a child in the cemetery on July 3<sup>rd</sup>, having been brought under the notice of, and discussed by the Council, the matter be allowed to drop.

**Chairs to be purchased.**

Proposed by Mr. William Collett, seconded by Mr. Reginald J. Kidman, and resolved that Mr. William Thompson purchase eight chairs (not nine as specified in resolution of April 18<sup>th</sup> 1904 p. 93), and select a suitable place for storing them.

Correspondence with John Evison Esq're dated July 12<sup>th</sup> & 13<sup>th</sup>, Mr. S. G. Cook dated July 14<sup>th</sup> & 15<sup>th</sup>, and the Surveyor of Taxes, dated August 11<sup>th</sup> '04, was read.

Also, Messrs. Orriss & Reeves' Statements showing the letting of the Gravel Pits to have realised £2.7.0.

### **Representative School Manager, Election of.**

Proposed by Mr. Albert Henry Ingle, seconded by Mr. William Thompson Jun'r, and resolved that Mr. George Thompson be elected Representative Manager for the Upwood (non-provided) School for the three years ending April 15<sup>th</sup> 1907.

### **Allotment Rents, Time for receiving.**

Proposed by Mr. George Thompson, seconded by Mr. Albert Henry Ingle, and resolved that the Council receive the Allotment Rents at the National School, on Friday the 21<sup>st</sup> inst. at seven o'clock in the evening, and that the members present attend if possible.

### **Allotment applications deferred.**

Leonard Poulter and George Kennell applications re Allotments were deferred until the Rent night.

### **"Jubilee Well" Indenture to be signed.**

The Chairman submitted agreements re the 'Jubilee Well' when it was proposed by Mr. Reginald J. Kidman, seconded by Mr. William Thompson, and resolved that the Indenture dated January 30<sup>th</sup> 1899, made between Mrs. Mary Ann Speechley and the Parish Council, be signed in duplicate and entered on the minutes.

**“Jubilee Well” Copy of Indenture.**

This Indenture made the Thirtieth day of January one thousand eight hundred and ninety nine Between Mary Ann Speechley, the wife of William Speechley of Woodwalton in the County of Huntingdon, Farmer, of the one part, and the Parish Council for the Parish of Upwood, in the said County of Huntingdon, hereinafter called ‘the Council’ of the other part.

Whereas the said Mary Ann Speechley is the Owner in **fee simple** of certain land in the said Parish of Upwood wherein a well was in the year one thousand eight hundred and ninety seven sunk, and from which well water is now being drawn for the purpose of supplying the inhabitants of the said Parish of Upwood therewith and which well is called the “Jubilee Well”.

In English law, a fee simple or fee simple absolute is an estate in land, a form of freehold ownership. It is a way that real estate and land may be owned in **common** law countries, and is the highest possible ownership interest that can be held in real property.

And whereas the said Mary Ann Speechley has agreed to let to the Council the said well for the term of fifty years at the yearly rent of Two Shillings and Sixpence.

Now this Indenture witnesseth that the said Mary Ann Speechley hereby demises unto the Council All that the said well in the Parish of Upwood aforesaid together with right of ingress and egress thereto and therefrom from and to the village street by themselves or their servants for the purpose of opening, deepening, altering or repairing the same as from time to time may be necessary and together also with the right to lay pipes to the said well from the said street through the land of the said Mary Ann Speechley for the purpose of drawing the water from the said well.

To hold the same unto the Council for the term of fifty years from the First day of January instant yielding and paying during the said term the yearly Rent of Two Shillings and Sixpence in every year such yearly sum to be paid on the First day of January in each year.

And the Council covenants with the said Mary Ann Speechley to pay the rent hereby reserved in time and manner aforesaid. In witness whereof the said Mary Ann Speechley and the Chairman and two other members of the said Parish Council of Upwood have hereunto set their respective hands and seals the day and year first above written.

**Relief Payroom, Proposed removal.**

The Chairman having drawn attention to the inconvenience caused to the old people by having to go to 'Little London' for relief pay, it was proposed by Rev'd John F. Cooksey, seconded by Mr. Reginald J. Kidman, and resolved that Mr. Arthur Gee, the Relieving Officer, be requested to pay the relief at Mrs. Slack's in the village if agreeable to the Board of Guardians, and that Mr. William Collett be advised hereof.

**Storage of Chairs, proposed to be purchased.**

Mr. William Thompson informed the Council that he had not purchased the chairs, authorised at the last meeting, as it was desirable that some place should be fixed upon for storage prior whereto. It was proposed by Mr. William Thompson, seconded by Mr. Albert Henry Ingle, and resolved that the Clerk write to Mr. S. G. Cook, Clerk of the Huntingdonshire Education Committee and ascertain whether the Parish Council has the right or power to store, say eight or nine chairs on the School premises, which would not inconvenience anyone.

**Lamp, query as to Ownership.**

A discussion arose as to whether the lamp erected near the Church belonged to the Church or the Parish, and it was proposed by Mr. William Thompson, seconded by Mr. Albert Henry Ingle, and resolved that the Chairman be requested to look up any papers or information referring thereto which he may possess.
