Minutes from meetings dated: 10th January 14th March x 2 10th October 18th April

Lodge Farm Allotment Fence.

The Clerk reported that Mr. P. L. Rogers had complained of the Lodge Farm Allotment Fence, stating that some of the posts were not fixed sufficiently firm, and the wires were sagging. It was proposed by Colonel Mowbray, seconded by Mr. Reginald Job Kidman, and resolved that Messrs. William Collett and George Thompson be appointed a Committee to deal with the same.

Correspondence.

The Clerk submitted letter dated 7th April 1910 from the Parish & District Councils Association for England & Wales together with Memorandum setting forth the object of the Association, when it was ordered to be laid on the table.

Lodge Farm Allotments Grip.

Resolved that making of the grip outside Lodge Farm Allotments be deferred until Michaelmas.

Clerk's Salary.

On the Clerk's Salary coming up for consideration, he reminded the Council that he had not received any remuneration for collecting Lodge Farm Allotment Rents taken up at Michaelmas 1908; he had spent two days in attendance on the Assessment Committee to adjust the Assessments & others; similar work would have to be done this year for the Common Farm Holdings and he had to pay 7/6 per annum as a guarantee.

Under these circumstances he hoped the Council would increase the salary from £11 to £13 per annum.

The Clerk retired, and on returning the Council informed him that they would grant an increase to £12, this they confirmed, but the Clerk said he did not see his way for accepting less than £13.
