

Minutes

The minutes of the last meeting were read and confirmed.

Chairman.

It was resolved on the proposition of Mr. J. H. Key, seconded by Mr. W. M. Scarr that Mr. A. H. Ingle be Chairman of the Council for the ensuing year.

Overseers.

It was resolved on the proposition of Mr. W. M. Scarr, seconded by Mr. J. Gaunt that Messrs. J. H. Key and F. Townsend Jr. be appointed Overseers for the ensuing year,

Managers.

Proposed by Mr. J. Gaunt, seconded by Mr. J. H. Key that Mr. W. M. Scarr be appointed a representative Manager upon the School Board. Carried.

County Council.

That Mr. J. Coleman be recommended for nomination as a representative member upon the Hunts. Education Committee, proposed by Mr. Townsend, seconded by Mr. Scarr.

Allotments.

Messrs. J. H. Key and A. H. Ingle who were appointed to inspect the Dyke in the Dock Allotment Field reported that the Dyke required doing out, and recommended that the adjoining gateway belonging to Mr. Shelton should also be done out, to effect better drainage.

Proposed by Mr. Scarr, seconded by Mr. Sinclair that the recommendation of the Committee be carried out as soon as Mr. Shelton had done his part and that the Clerk write to Mr. Shelton pointing out what was necessary and should be done by him. Carried.

Accounts.

The Accounts for the year ending 31st March 1925 having been submitted to the Council were adopted on the proposition of Mr. J. H. Key, seconded by Mr. W. Sinclair.

Clerk & Salary.

Resolved on the proposition of Mr. F. Townsend, seconded by Mr. Gaunt that Mr. T. Greenwood be re-appointed Clerk to the Council, and that his salary from the 1st April shall be after the rate of Twenty Pounds per annum.

Fowl Straying on Allotments.

The Clerk was directed to write letters to Miss A. Thompson and Mr. H. Slack requesting them to take steps to prevent their fowl straying upon the Allotments.
