

Resolved that a Parish Meeting be called by Poster to make arrangements for local celebrations of the Silver Jubilee of His Majesty The King.

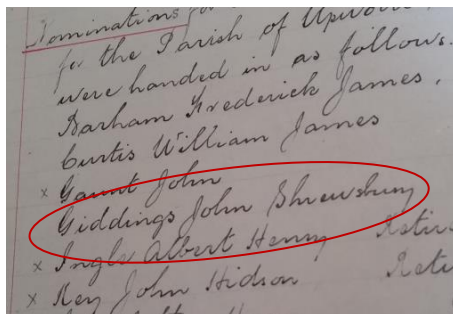

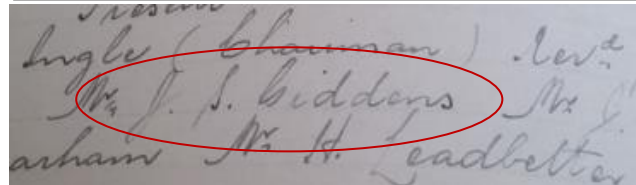
Upwood and the Raveleys Parish Council
