Correspondence.

A letter was read from Lord De Ramsey expressing his willingness to reduce the Rent of Hill Farm Allotments to £20 per annum.

Arrears.

The Clerk reported that Messrs. C. & H. Gaunt, J. Gaunt and W. Edwards had not paid their Michaelmas Rents, and the Clerk was directed to write them again and report at the next meeting.

Water Supply.

Questions were asked about the New Water supply which were answered by Mr. Curtis, R. D. C.

Nuisance, Magpie Alley.

The Clerk was directed to write to the R. D. C. with reference to a nuisance existing at Magpie Alley, Great Raveley and to request that same be removed.

Chairman.

Resolved that Mr. A. H. Ingle be Chairman and Mr. W. J. Curtis be Vice Chairman for the ensuing year.

Sewer Replacement.

A letter was read from the Clerk to the R. D. C. stating that the Council had under consideration the condition of the sewer between the school and the bakehouse at Upwood which they had been advised was a bad sewer and the only course open was to lay a fresh sewer.

The R. D. C. had been in communication with the County Council, who are prepared to pay half the cost which would be approximately £65 and the remaining half would have to be borne by the Parish and levied by a special rate, and asking for the views of this Council upon the matter.

Resolved, that after careful consideration, this Council is of opinion that the suggested work is necessary but that the estimate of £65 is somewhat excessive and that the proposed rate should be levied and spread over a period of three years.

Order of the Charity Commissioners.

The Clerk laid before the meeting an Order of the Charity Commissioners dated 1st day of October 1937 in the matter of the Charity called or known as the Poors Allotment in the Parish of Great Raveley as follows:-

"The power of appointing two trustees of the above mentioned Charity which was exercisable by the Parish Meeting of Great Raveley before 1st April 1935 shall henceforth be exercisable by the Parish Council of Upwood and the Raveleys".

The Clerk laid before the meeting an Order of the Charity Commissioners in the matter of the Charity of Elizabeth West in the Parish of Upwood dated 1st October 1937 as follows:-

"The power of appointing four trustees of the above mentioned Charity which was exercisable by the Parish Council of Upwood before the 1st April 1935 shall henceforth be exercisable by the Parish Council of Upwood and the Raveleys".

Trustees.

Resolved "That Messrs. M. Lowings and G. W. Brighty be appointed Trustees of the Poors Allotment Charity, and Messrs. W. J. Curtis, F. J. Barham, F. W. Lantaff and F. Townsend be appointed Trustees of the Elizabeth West Charity".

Rating.

Resolved "That Messrs. A. H. Ingle and H. Leadbetter be appointed as Members of the Rating Committee appointed by the District Council in connection with the third quinquennial valuation".

Allotment Audit.
