2. Minutes

3. Matters arising

(a) Church Lane - progress

A reply had been received from Cambridgeshire County Council and the contents were thoroughly discussed. It was finally proposed by Mr. Gaunt and seconded by Mr. Gowler that representation should be made to County Councillor Mrs. W. Price. This was agreed unanimously.

After some discussion it was proposed by Mr. Bowman and seconded by Mr. Racey that the Parish Council should write to the Chief Superintendent at Thorpe Wood in support of P.C. Thompson's report. This was agreed.
