Resolved on the proposition of the Rev. E. F. Hemming seconded by Mr. F. J. Barham that Mr. A. H. Ingle be Chairman of the Council for the year ensuing.

Clerk.

Quit Rent.

The Clerk read a letter from the Steward to the Lord of the Manor with reference to the Law of Property Act 1922, the land belonging to the Parish Council became freehold as from 1st January 1926, but that the Quit Rents and other incidents of Tenure still remain payable until they have been

extinguished in accordance with statutory provisions. The steward also said he would quote terms for extinguishing the Manorial incidents on receipt of particulars from the Council.

The Clerk was directed to ascertain the Terms of extinguishment of the Quit Rent and report to a later meeting of the Council.

School Manager.

It was resolved on the proposition of the Rev. E. F. Hemming seconded by Mr. Sinclair that Mr. F. J. Barham be appointed the Council's representative upon the School Managers for a term of 3 years.

Pump.

Resolved that Messrs. Barham and Murfin carry out the necessary repairs to the Village Pump under the superintendence of the Chairman.

Paths.

The Clerk was instructed to obtain from Mr. W. Scarr a quotation for 4 yards of sifted gravel for Public Path, price to include carting.

Accounts.

The Clerk presented the Parish Council Accounts for the year ending 31st March 1928 which were adopted on the proposition of Mr. Barham seconded by Mr. W. Sinclair.

Repair to Path.

The Clerk was directed to write Mr. W. Edwards requesting him to fill up the ruts which he made when carting over the Parish Paths, failing which the Council will do the work and charge Mr. Edwards with expenses.

The meeting had been specially convened to consider what should be done to the Pump at the east end of the Village, the pump had been opened and there was an adequate supply of water in the well, but the opinion had been expressed that the Lead service pipe under the road had been crushed by heavy traffic thus preventing the flow of water.

It was resolved on the proposition of Mr. J. H. Key seconded by Mr. F. Townsend that the Pump be moved to the opposite side of the road, and that the pump be re-cased and properly fenced.

Resolved that estimates for casing pump and fencing same be obtained from Mr. C. Murfin and Mr. G. B. Ashby and that Mr. Hildred do the plumbing.

Notices to Quit.

The Clerk reported that Notices to Quit the land held under the Council as on the 11th October had been received from Messrs. A. H. Ingle and C. Elmore.

Quit Rent.

A letter was read from the Steward of the Manor with reference to the extinguishment of the Quit Rents and Memorial incidents, to which the Councils Land was subject, and stating he was willing to advise the Lord to accept 20 years purchase of the Quit Rent say £7 plus the costs of the deed. The matter was again discussed and resolved that the extinguishment of the Quit Rent be not proceeded with.

Gravel for Path.

A quotation from Mr. W. M. Scarr for 4 yards of Gravel for the Parish Paths at 13/- per yard delivered was laid before the Council.

Resolved on the proposition of the Rev. E. F. Hemming seconded by Mr. J. Gaunt that the Gravel be ordered, subject to it being double sifted Gravel.
