1. Welcome by Councillor Robin Howe

Councillor Howe welcomed parishioners to the meeting.

2. Apologies

Apologies were received from Councillor Michael Tew. His attendance was required at another meeting.

3. Minutes of the Annual Parish Meeting

To receive and approve as a correct record the minutes of the meeting held on 13 May 2013:

Councillor Howe reported with regret that the minutes of the previous meeting were unavailable. The Clerk has made considerable attempts to locate the document, and has spoken with the previous Clerk on this matter. Copies of reports presented at the meeting are available and these will be published on the website.

4. Report from the Chairman of Upwood & the Raveleys Parish Council

The Chairman outlined the achievements of the Parish Council over the last twelve months. Notable successes include:

- · the progress of the Community Led Plan
- the development of the portfolio system of councillor responsibilities.
- increased independence of the allotment association from the Parish Council and significant progress in untangling the history of the land and the charities under which they are governed.
- · improved management and maintenance of parish grass and hedgerows.
- significant improvements in the financial management of the Parish Council (including a surplus to be carried forward into reserves for the new financial year).

The Chairman recognised the (voluntary) work of the Clerk and noted that "the Council has never been so well supported, nor had such a strong supporting infrastructure which complies with District and Parish rules."

Report from the District Councillor

Councillor Robin Howe outlined the impact on Parish and District Councils following the removal of government subsidies and grants. He updated parishioners on the financial savings achieved so far and those needing to be achieved in future years. A Strategic Partnership is planned with South Cambridgeshire District Council with a view to sharing resources and combining services.

Councillor Howe assured parishioners of his strenuous opposition to the District Council's proposal that the five parishes of this Ward (the Central Clay Lands) would have a "high" capacity to accept up to 12 wind turbines.

The District Council have accepted that Community Led Planning is an important adjunct to Neighbourhood Planning and it is expected that both practical and financial support will be forthcoming. A meeting of the five Parishes of this Ward will be held on 19 May with a view to sharing knowledge, examining synergies and raising awareness of the benefits of the initiative.

It is expected that improvements to the infrastructure and management of the Secret Garden Party will lead to increased visitor numbers, but with the same or lower noise levels. Matters of security, traffic management and post-event reporting are also being addressed.

Report from County Councillor

Councillor Michael Tew's report emphasised the need for the County Council to reduce costs and increase revenue streams without compromising the delivery of services to the most vulnerable. Council Tax has been increased by 1.99% to maintain the core services.

It is hoped that Upwood and the Raveleys will be upgraded to "Superfast" Broadband by September 2014.

The Cabinet will be dissolved on 13 May 2014 and the Council will operate as five committees.

The "Older People's Programme aims to improve health and social care services within Cambridgeshire and Peterborough.

Councillor Tew's report concluded by reminding parishioners that work to update street lighting is scheduled for June.

6. Financial report from the Clerk to the Council

The Clerk summarised the income and expenditure of 2013/2014 and highlighted notable achievements and benefits to the parish as a result of the Council's expenditure. She noted that a positive meeting had been held with the Internal Auditor and is confident that his report will reflect well on the financial management and operation of the Parish Council at this time.

7. To invite the public to raise any matters of interest

There were no additional matters of interest.

8. Questions for the County and District Councillors

There were no questions.

9. Chairman's Closing Remarks

The Chairman concluded by thanking those who had taken the time to prepare reports for this meeting. This is a "fantastic, vibrant Parish, full of enthusiasm" and we should all be thankful for the variety of leisure, educational and social opportunities available to us and provided for us by so many willing volunteers.

Councillor Howe thanked the Parish Councillors who have overcome the financial difficulties of the past; and have embraced the move to overhaul procedures and practices. As we continue to improve, Councillor Howe noted that he and the Clerk had agreed that the Council should aspire to gaining "Quality Status". Very few councils in the District have achieved this and although further work and energy is required, it is within the reach and capabilities of this Council and would be a fitting turning point in the history of this Parish.

Councillor Howe reflected that Mrs. Sharon Whitelaw, Headteacher of Upwood Primary School had noted in her report, aspirations to improve links with the local community. He added that nurturing and improving community relations would be high on the agenda for the Parish Council in the forthcoming year. He suggested that he would like to see Councillors working with children in the school and for a group of children to attend the Annual Parish Meeting in future years to share their experiences with Parishioners.

UPWOOD and the Raveleys Parish Council Chairman's Report May 2014

Upwood and the Raveleys Parish Council have met eleven times in official session It has not been necessary to arrange extraordinary sessions during this year. Financial reviews have been undertaken by the Finance subcommittee on a quarterly basis and site meetings have been held with one or more Councillors wherever a major planning application has been submitted within the parish.

Twenty one planning applications have been reviewed by the Council during the year.

Fiona Hopkins and her team have made steady progress with the Community Led Plan and there has been strong engagement by all members of the project team. The questionnaire is soon to be distributed to residents and the results will be eagerly awaited.

The Chair attempts to restrict the Council meetings to two hours; but this is sometimes difficult to achieve. Requests have gone out to Councillors to read the meeting papers carefully in advance and to bring forward only those points of contention or clarification to the meeting. This will reduce the need to review and discuss documents in detail during the meeting.

The development of the Portfolio system of Councillor responsibilities has helped improve the infrastructure and governance of the Parish and is also helping to shorten the debating time but more can still be done to improve meeting efficiency.

Notable successes include the move to making the Allotment Association independent of the Council along with the work to untangle the history of the land and the charities to which they belong.

Grass verges and hedgerows are better tended than before thanks to the planning and management work of Cllr. Sisman and to the free grass cutting service provided by Mr Don Manchett, who sadly will leave the Parish this year.

Relationships with the Parish newsletter committee, the Village Hall committee and the Church have all improved through the year due to the good work of Councillors although more could still be done to improve links with Upwood County primary school and the residents associations in Fairmead and Farm Close. These will become a priority for the coming year.

Parish finances have shown a notable improvement in the year and the Council is carrying a surplus forward into the new financial year which will bolster reserves. Some of the savings derive from the fact that the new Clerk, Carol Bilverstone has worked without pay through the year to comply with appointment rules for Parish Clerks.

Carol had no prior experience in this post but has shown a tremendous energy and determination not only to learn the complex procedures and financial rules but also

to completely review the administrative and control systems which should govern a parish council.

Thanks to her endeavours the Council has never been so well supported nor had such a strong supporting infrastructure which complies with District and Parish rules.

The year ahead will see the completion of the Community Led Plan and this will lead to a wide range of proposed improvements to our amenities and services. We now have a Council at full complement which, with our increased collective experience and improving systems and supported as we are by an excellent Clerk can promise to serve the residents of the Parish even better in 2014/15.

Upwood and Raveley Community Allotment Association (URCAA) and Upwood Community Orchard

Update for Parish Council, May 2014

This is the third year of the allotment association and despite some 'interesting' weather over the last couple of years we are progressing with our short, mid and long term plans for the allotments. Of course, our main aim is still to get plot holders actively growing and to stay growing. The BBC 'Great Allotment Challenge' programme - soil that crumbles in your hands, greenhouses, walled garden - doesn't appear to have much in common with our challenges – heavy soil, wind, water (too much/not enough) and abundances of wildlife and weeds! However, by varying the plot sizes to match peoples need/time available, we hope that the allotments can be an enjoyable and manageable activity for everyone.

For many the most noticeable change at the Upwood allotments will be the Meadow Road access, where there is now a barrier gate installed. We are following up funding options to install a similar gate on the Huntingdon road as well as applying to the Woodland Trust for hedging to fix some of the holes in the hedges.

Our next group allotment 'work' day is the 29th June - even if you don't have a plot but would like to join in the activity please come along.

This year we have also started a community orchard within the Upwood allotment area. Following a highly successful planting day we now have 15 local variety apple, gage and plum trees, sponsored by villagers, growing in the orchard area. There is still room for more trees, which we hope to utilise next Spring, and there are plans to plant lavender and rosemary bushes as well as wild flowers in the area. A bench has very kindly been donated by residents of the village and we are working to get it in place as soon as possible. It's very early days but we hope that the orchard is an area that all villagers can enjoy for many years to come.

On the 12th July we are holding a fund raising quiz for the orchard in the village hall - we hope to see you there.

Links With Our Community Which We Value

Manor House

Our strong links with Manor House have been maintained this year as we once again collected toiletries for the residents during October. Pupils in Year 2 and Year 5 delivered the items to the residents after visiting St Peter's Church for a 'Harvest Festival' of their own. Residents also came to Upwood Primary School to watch the children perform their Dress Rehearsal of 'The Stars Come out for Christmas'. Residents were also invited to our annual May Day celebration, which focused this year on 'Dances From Around the World'.

St Peter's Church Service

On Monday 16th December, the whole school walked to St Peter's Church in Upwood for a Christmas Service planned by the school. The children performed a variety of songs and poems. We were once again welcomed warmly into the church.

Open the Book

Each Thursday, trained members from St Peter's Church visit Upwood Primary to deliver an assembly called 'Open the Book'. The members use a variety of engaging techniques to deliver stories from the Bible. Our pupils look forward to the assembly each week and we would like to thank the trained members for their continued support.

PTA

We are extremely fortunate at Upwood to have a very high degree of involvement and commitment from our community. The PTA organisation is actively involved in a full programme of educational, social and fund raising activities, for both children and adults, from which the school benefits greatly. This year, the PTA ran their first ever 'Pop and Popcorn' event, which was very well received by the children.

Charity Work

We believe our pupils gain a great deal from taking part in fundraising events for both our school and national/international charities, as it develops empathy towards others, a sense of community and an understanding of the wider world. We agreed to support the following three charities for this academic year:

- Operation Smile;
- The Poppy Appeal;
- · Sport Relief.

Operation Smile is an International Charity providing free surgery to repair cleft lips and palates for children. As it focuses on improving the lives of young children, this charity was very close to the hearts of all members of our school community. On the final day of the Autumn Term, children were asked to come to school in something that would make someone smile! A wide range of bright and colourful costumes were seen in school. Families made a contribution to the charity 'Smile' on this day.

Sport Relief is one of our nation's great fundraising efforts, which brings the entire country together to be physically active and raise money. Informally, parent and carer feedback last academic year suggested that our pupils would benefit from being involved in such a high profile event. Therefore, Upwood Primary School took part in the Sport Relief effort this year, completing a mile long obstacle course in March.

We also continued to support the Poppy Appeal. Children were asked to make a voluntary contribution to an appeal box, in exchange for a Poppy pin. Staff felt that it was important to continue with this fundraising event, as it is has such great significance in our nation's history.

Special Events

Catering Workshops

Upwood Primary School pupils had the opportunity to develop their cookery skills in January. Each year group, from Foundation to Year 6, welcomed Carole Youngman and her team ('Cooks on the Move') from Cambridgeshire Catering Service into their classes. Staff at Upwood Primary School consider cookery to be a key part of the curriculum, as it develops independence in later life and can foster an interest in healthy eating. Overall, the aim of the workshops was to give the children a greater understanding of where food comes from and how to create a tasty dish from scratch using healthy ingredients.

With the 'Cooks on the Move' the children made fruit crumbles, bread and pizza and were taught many cookery skills including mixing, kneading and chopping safely. At the end of the session each child was able to eat their cookery project; staff felt that this part of the session was enjoyed the most!

Cricket Masterclass

Some pupils from Upwood Primary School met Sports Personalities Charlotte Edwards and Jenny Gunn, Captain and Vice-Captain of the Women's England Cricket Team in September

2013. Six Year 6 girls from Upwood developed their cricket skills with the well-known sports women on Tuesday 24th September in Ramsey.

The session began with some fun warm-up activities that incorporated key skills needed to play cricket successfully. The England stars then provided a personal coaching session for the pupils and they were given tips and advice on how to improve their game. After the session, Charlotte and Jenny spent time with the pupils taking photographs and signing autographs. The children clearly had an amazing afternoon spending time with these two inspirational cricket stars.

CHAIRMAN'S REPORT TO THE ANNUAL GENERAL MEETING

April 2014

Bookings in 2013 continued to remain strong particularly with the ever increasing popularity of the Table Tennis club which is now running a daytime session and the formation of a new book club. However we regret the loss of the 55+ group which was unfortunately disbanded at the end of last year.

In a similar vein the Pantomime was another huge success with packed houses for each performance. The Old Woman Who Lived in a Shoe was the 20th Upwood Pantomime and over the years has grown from strength to strength gaining increasing popularity (or should that be notoriety?) and winning a number of regional awards. Unfortunately however a number of the long-standing members of the Pantomime team have decided that after 20 years it is time to stand down. Whilst a Pantomime is a massive undertaking it would be a huge loss if this were the last show as there is so much talent in the village and the shows provide a great deal of enjoyment. Perhaps a few people may be inclined to form an Upwood Drama Society and initially put on some smaller shows and in due course consider re-establishing a pantomime?

Meanwhile outside Arts events have continued to be a popular attraction and have appealed to a wide range of tastes from music based shows to ghost stories! Our thanks again go to Doug McLeod and his team for arranging these.

During the past year we have continued our refurbishment programme with the installation of new fire doors which not only has improved safety, security and insulation but has also reduced draughts.

In 2014 we aim to continue our refurbishment and I am pleased to announce that within the past month we have been awarded a full grant from WREN for the replacement of the ceiling in the front hall which we hope will massively reduce our heatloss. We expect that the grant money will be forthcoming in the next few weeks and that the work will be carried out over the summer months.

As always, costs continue to rise and unfortunately after 3 years it has recently been necessary to raise our hire charges. We have decided to increase the hourly hire rate mainly to cover the background heating costs however our electricity charges have remained unchanged consequently many hirers will see little overall increase as they are likely to spend less on their electricity for heating.

Once again our thanks go to all of our fundraisers who enable us to invest in major projects such as the heating and to the Parish Council who's grant helps us to cover our insurance costs.

Last but not least, my sincere thanks go to the Village Hall committee and its trustees whose tireless efforts continue to ensure that the hall remains a valuable community resource.

Financial Report from the Clerk to the Parish Council

In 2013/14 the Parish Council worked with a budget of £20,860 and at the end of the financial year had underspent on that budget by £4,566.42.

Notable expenses and achievements of 2013/14 include the completion of phase one of the tree works to St. Peter's Churchyard; funding of training for the Certificate in Local Council Administration for the new Clerk (this is the Statutory qualification for Clerks and I intend to qualify in the next couple of months); the purchase of a dedicated Parish Council laptop for use by the Clerk; financial support to the newsletter, the village hall and the village fete; the purchase and installation of a barrier gate on the Meadow Road allotments in partnership with Upwood and the Raveleys Community Allotment Association; the upkeep and maintenance of parish grass and hedges; and considerable legal fees to renew the lease of Glebe Paddock for a further 10 years.

Comparing the forecasted budget with the actual amount spent in 2013/2014, there are four notable variances:

- The current Clerk is a volunteer. There has been no expenditure on the Clerk's salary since the resignation of the previous Clerk. This has been a significant saving to the Council.
- o It was intended to complete the work on the noticeboards in 2013/2014. The budget for 2014/2015 has been amended in order to carry this proposed expense forward.
- The rent for Glebe Paddock due in October 2013 was not paid as renewal of the lease has taken considerable time. Three rental payments rather than two will therefore be recorded in 2014/2015.
- The Parish Council holds funds on behalf of URCAA. No mechanism for payments to, or in support of URCAA had been included in the budget for 2013/2014. This was rectified towards the end of the financial year and is in place for 2014/2015.

Income for 2013/14 came from a precept of £19739; and a modest income from the rental of allotment plots and farmed land; and from the cemetery.

As we start the new financial year, 2014/2015, the Parish Council carried forward a balance of £23,366 and has a precept of £20,000. The working budget for the year will be £24,210.23.

Plans for the new year include the completion of phases 2, 3 and 4 of the tree works in St. Peter's Churchyard, together with ongoing support to the village hall, the newsletter and continued upkeep of the parish grass and hedges. The Parish Council hopes to complete maintenance and refurbishment works to the noticeboards and has made provision for remuneration for a Parish Clerk with effect from 01 August 2014.

I met with the Internal Auditor last week and hoped to be in a position to share his report. However, this has not been received at the time of writing. The meeting was positive, the auditor was thorough, and I am confident that his report will reflect well on the financial management and operation of the Parish Council at this time.

ANNUAL DISTRICT COUNCILLORS REPORT TO UPWOOD and the RAVELEYS PARISH COUNCIL MAY 2014

Introduction

2013/14 has been a year of considerable change to Parish and District Councils. The removal of government subsidies and grants to the District councils has meant cuts in funding to the parishes with the corresponding tightening of the belt needed. Parish councils are becoming accustomed to funding services which have traditionally been dealt with by County or District resources and this is placing further pressure upon Parish finances.

Council employees have suffered a year of great turbulence; a large number have involuntarily left their posts while all have been subject to a salary review which has resulted in 50% taking a cut in their annual income.

These measures have been forced upon the Council because of the cuts in funding mentioned above; but it has resulted in a workforce who is not yet fully motivated nor manned to perform their tasks.


This is leading to service delays in the planning and housing departments and extended response times across all sections.


This situation will no doubt improve as the year goes on when management and staff come to grips with the new workload but until then residents may have to endure a reduced level of service.

Financial Update

As we have now reached the end of the financial year, it is a good opportunity to focus on what has been achieved and what further savings still need to be made. There will be an under spend of £2.1m against the original 2013/14 budget of £22.8m due to the concerted efforts to find savings and efficiencies. Details of the under spend will be circulated once completed and while this is positive news; however, further cuts in government funding are coming and the Council cannot be complacent. A further £1m must be saved from the current financial year's budget (2014/15) and a further £0.7m during 2015/16 but these aims are likely to be achieved as a result of Facing the Future saving review which has recently been completed.

The pie charts below show how the budget is spent, and where the income comes from.





The Council are examining every area of expenditure and every asset it owns to try to release greater efficiencies in an effort to achieve a balance budget in the next two

years and to reduce the burden on tax payers by holding to zero Council Tax increases

Service areas which can yield an economic return, such as the One Leisure group, the Document Centre and the CCTV network, will in future be subject to a more commercial approach, without sacrificing the customer service and quality standards which their customers expect.

Much emphasis is being placed upon sharing services with adjacent authorities such as the recently announced deal to operate Cambridge City's CCTV network through the HDC Control Centre

An example of shared services on a larger scale is the recently announced planned strategic partnership with South Cambridgeshire District Council (SCDC). There are many synergies between the two councils. SCDC also have tough savings targets, and like HDC, face further cuts in central government funding. Cabinet members have had a meeting with the Cabinet members from SCDC and have agreed in principle to work more closely together. Initially, the sharing of Building Control service is being planned, with staff from both Building Control teams are now working together to look at what mutual benefits there are from sharing this service.

Services across both councils will be looked at to see what benefits (if any) could be gained by working more closely together. We are also looking at the advantages of joint recruitment and possibly joint appointments. Sharing with SCDC gives the opportunity to have bigger teams and support additional specialists across the two councils. This means that we can help each other on large or under-resourced projects

Renewable Energy Policy

The Council have recently published a draft revision called Wind Energy Development in Huntingdonshire 2014 which aims to assist in the interpretation and application of the location of renewable energy schemes.

There are at present nine separate landscape areas in Huntingdonshire of which five currently have wind farms installed or consented; around 32 large turbines in total.

The proposed SPD defines the capacity of the other areas to accept wind farms and with the exception of the Ouse Valley; all remaining areas could see turbines installed in future.

This means that the landscape region containing the five parishes of this Ward (the Central Clay lands, including Upwood Parish, would have a 'high' capacity to accept up to 12 turbines.

The writer is strenuously opposing these proposals and will argue accordingly in Cabinet meetings.

Consultation ends on 9 May but residents are free to write to me expressing their opinion at any stage in the next month.

Community Led Planning

I am pleased to report that the District Council have now accepted that Community Led Planning will receive more of their support; both practical and financial in future..

It has now been accepted that the CLP process is an important adjunct to Neighbourhood planning which is the judicial process governed by local referenda.

The preparation of the plan by local people, covering as it does amenities, welfare, recreation and housing enables a more ordered approach to be taken to future planning matters.

The Upwood CLP development process has received excellent support from residents and an active project team has now completed the questionnaire for imminent distribution.

I have organised a meeting on 19 May to which all five parishes are invited with a view to sharing knowledge, examining synergies and generally raising awareness of the benefits of Community Planning.

The meeting will be attended by Jo Lancaster Managing Director of HDC and Kirsten Bennett, Managing Director of Cambridgeshire ACRE, both of whom will speak on the subject.

Secret Garden Party

A meeting was held on 6th May between members of the Secret Garden Party organising team and selected residents from local villages to review the arrangements for this year's event.

The agenda covered noise management measures, security, traffic management and post-event reporting.

HDC was represented by Richard Hollingsworth Environmental Officer, who explained the monitoring and reporting systems to be installed.

More sound monitoring equipment will be installed to the North of the site this year (Woodwalton and Wennington) as a result of increased complaint levels from residents last year.

The SGP organisers claimed that they will have 10-15% more visitors this year (still within permitted licensing limits) but that noise levels will be the same or lower than last year due to improved attenuation systems and to changed positioning os sound stages.

The festival traffic will not be allowed to use the Sapley road towards the Kings Ripton crossroads but local residents will be issued with car permits to allow for local access as last year.

Report by county councillor

Cambridge County Council has made significant steps towards reducing costs and increasing revenue streams over the last 12 months, but as local authorities are faced with an increasingly difficult financial environment the council is now exploring a wide range of options that will make further financial savings. The council's aim is to reduce costs, as far as possible, without compromising the delivery of services to the most vulnerable.

Council Tax

The County Council has increased the council tax by 1.99 percent; the reasons for this rise are to keep the core services i.e. social care for adults and children and the elderly which is an ever increasing cost to the budget which has been cut by 38 million in 2014-2015 it is true it that we have a duty to the Council Tax payer, we also have a duty to the most vulnerable in Cambridgeshire, to do everything we can to maintain those core services.

Broadband Roll out

The superfast broadband rollout is on track, to date 88 new fibre cabinets were live at the end of April 2014, over 19.000 homes and businesses over the county now have access to this service.

Kings Ripton - is now live

Upwood + raverleys - hoped to be upgraded by September 2014

Abbots Ripton - hoped to be upgraded by September 2014

Woodwalton - hoped to be upgraded by September 2014

Cambridge County Council will be changing from May 13 2014

The cabinet will be dissolved on the above date, the running of the council will be ran by a committee system comprising of 5 committees each having an all-party presence of 17 members per committee this should make the decisions more democratic, it will be interesting to see how this pans out in the next few months.

CCG Cambridge and Peterborough,

Are now in the public consultation phase, The Older People's Programme aims to design and buy-in health and social care services for a defined population of older or vulnerable patients within the CCG's area. The aim is to deliver improved patient experience, better community care and reduced unplanned admissions to hospital where these can be safely avoided.

Local Issues

Locally The PFI roll out between the county council and Belfour Beatty is set to go ahead in june you will be seeing white paint with sl on some pavements, I have also given Councillor slater details of the liaison office that's dealing with parishes, if you get in touch with her she may be able to arrange a public surgery to alleviate any fears people may have.
