Mr Paine advised that he had been contacted by Peter Reeve in connection with the interpretation board. Clerk to email Vera Woolmer once more requesting again a photo of the board. It was discussed whether existing sign at the top of Meadow Road, directing to Nature Reserve, could be improved in any way.

Mr McCreadie mentioned there were numerous potholes in Great Raveley and that Highways were repairing some, but not sufficiently. Mr McCreadie also advised of problem between Highfield Bungalow and Plumtree House with water running off field and into the road. Water has nowhere to go because there is no ditch.

Mr Paine advised that he had correspondence from Gordon Slinn with regard to the closure of St Peter's Churchyard. Confirmation in an extract from London Gazette 1886 that Upwood was one of the churchyards to be closed.

Mr Paine advised that he had been contacted by Fiona Hopkins who had seen a resident exercising his dogs in the playing field and not clearing up excrement. Situation to be monitored.
